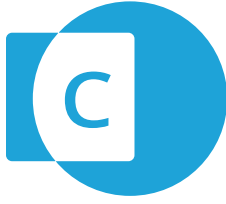
A2. Short quotations can be submitted in the original language with a translation into the state language of Ukraine.
